## SHARE SELECTION & PRICING

**Deposit** (due with signed agreement):  \$700 - Whole Hog  \$350 - Half Hog

**Price:** \$6.50 per pound hanging weight

## WHAT TO EXPECT

**Timeline:** Processing scheduled for early January 2025

**Processing Location:** Lind's Custom Meats (23022 172nd Ave SE, Kent, WA)

## KEY TERMS

**Deposit:** Non-refundable but transferable to future share.

**Balance Payment:** Due upon receipt of invoice, calculated based on your share's hanging weight as determined by the butcher.

**Processing Fees:** Paid directly to Lind's Custom Meats at pickup

**Meat Pick Up:** Customer picks up packaged meats directly from the butcher

**Weight Variation:** Final weight may vary; deposit adjustments available if needed

\$350	\$325	<b>Slaughter:</b> \$55 (half of \$110 whole hog fee) <b>Basic Cut &amp; Wrap:</b> \$85.50 (\$0.95/lb) <b>Optional:</b> Sausage (\$1.00/lb + \$10 per deboned ham/shoulder) <b>Optional:</b> Smoking (\$4.50/lb for hams, bacon, hocks)

**Total Estimated Cost:** \$732.50 (before optional processing)

\*Double all amounts for whole hog share
